Municipal Service Delivery : Jabalpur

The Municipal Corporation of Jabalpur(JMC) is responsible for providing civic services and development of utilities infrastructure for the citizens of the city. However the JMC does not work in isolation. It works with other government agencies and institutions for delivering their services smoothly.. The Jabalpur City Transport Service Limited (JCTSL) is responsible for providing infrastructure on public transport facility in the city. It also provides the service of smart parking through a central command centre for efficient revenue collection system. The PWD is responsible for planning designing and construction for roadways, bridges and flyovers in the city through contractors registered with the PWD. The Madhya Pradesh Road Development Corporation Ltd. (MPRDC) is responsible for the implementation of various schemes on transportation and to construct, operate and upgrade the major highways and district roads passing through the city. The RTO is responsible for registering the vehicles of the city. The water supply for domestic and commercial use in the city are met through Narmada river. The distribution of water in the city is done by the JMC. The JMC is responsible for new water connections in the city. The Public Health Engineering Department is responsible for the implementation of the schemes in the form of survey, exploration, planning report preparation and deposit form for water supply and sewerage drainage schemes in the city. The Madhya Pradesh Power Transmission Company Limited is responsible for intra state distribution and transmission of power in the city. Madhya Pradesh Power Generating Co. Ltd. is engaged in generation of electricity in the state of Madhya Pradesh as well as operating and maintaining its existing units along with constructing new Power Plants for increasing capacity. The Madhya Pradesh Poorv Kshetra Vidyut Vitaran Company Ltd is responsible for collection of the customer bill and addressing the grievances of the customer. JMC executes works related with installation of new street light poles as well as temporary lighting during fests, festivals and fairs. The JMC is responsible for installation and maintenance of public toilets in the city. The planning designing and laying of sewage pipelines is done by the PWD through registered private contractors. The JMC is responsible for collection, transportation, treatment and disposal of Municipal Solid Waste generated. The fire fighting and support during calamities is done by the fire department of the JMC. The management of open spaces, city gardens, city beautification and construction of residential complex's, community centres, shopping areas and office spaces, slum rehabilitation is the responsibility of Jabalpur Development authority. Hence for a single service multiple government agency work together. This requires coordination and cooperation so as to maintain the expected service delivery. However due to such delegated authority often there is delay in the delivery of services and accountability of services delivery cannot be vested on a single agency.
